Return this notice when you pay your second installment, or in case you pay the full amount of taxes prior to the first Monday of January.

The taxes shown on this notice are payable to the Tax Collector, without penalty, on and after the fourth Monday of November in the year in which such taxes are levied, and prior to the first Monday of January next thereafter; and all such taxes which have not been paid prior to the said first Monday of January will be delinquent and a penalty of 10% of all such taxes added thereto; Provided, That one-half of such taxes may be paid prior to the said first Monday of January and then and in that event, a penalty of 4% of the remaining one-half of such taxes will be added to said remaining one-half, and such remaining one-half of such taxes, together with the penalty added thereto, will be payable to the Tax Collector, without additional penalty, on and after the fourth Monday of January in the year succeeding the year in which such taxes are levied and prior to the first Monday of July next thereafter; and if such remaining one-half of such taxes is not paid prior to the said first Monday of July, an additional penalty of 6% of the original amount of such remaining one-half of such taxes will be added thereto and the property sold for delinquent taxes, subject to redemption on application to the County Auditor of said County within two years from the second Monday of January preceding on payment of the original amount delinquent with penalties added thereto and interest on the whole amount from the said second Monday of January, at the rate of 1 1/2% per month. In case all or one-half of the original amount of all taxes due is not paid prior to the first Monday of January in the year succeeding the year in which such taxes are levied, the property will be sold for delinquent taxes, subject to redemption on or after the fourth Monday of January in said year as hereinabove set forth.
