# $Principle - Witness \rightarrow Faith \rightarrow Action$

### Witness/Evidence produces Faith

• Hebrews 11:1

"Now faith is the substance of things hoped for, the *evidence* of things not seen"

- Romans 10:17
  "So then *faith cometh by hearing*, and hearing by the word of God"
- What is the role of the Holy Ghost?
  - 2 Nephi 33:1

"for when a man speaketh by the power of the Holy Ghost the power of the Holy Ghost carrieth it unto the hearts of the children of men"

• D&C 42:17

"For, behold, the Comforter knoweth all things, and beareth record of the Father and of the Son"

# • Why doesn't evidence always create faith?

- Hard heart (2 Nephi 33:2)
  - 2 Nephi 33:2

"But behold, there are many that harden their hearts against the Holy Spirit, that it hath no place in them; wherefore, they cast many things away which are written and esteem them as things of naught"

- Sin
- Unbelief (Mosiah 26: 3)
  - Mosiah 26:3

"And now because of their unbelief they could not understand the word of God; and their hearts were hardened"

#### Faith requires that we act

• James 1:22

" But be ye *doers* of the word, and not hearers only"

- What should we do?
  - 2 Nephi 32:1-5

"...feast upon the words of Christ; for behold, the words of Christ will tell you all things what ye should do...

receive the Holy Ghost, it will show unto you all things what ye should do"

- We can apply what we learn from the scripture to know how to be, say and do
- For those times where it is not spelled out the HG will guide us
- Why don't we act?
  - Fear
    - "Let faith guide your actions and not your fears"
    - "We react based upon our fears or we are acted upon"
  - Doubts
    - Joseph Smith

"For doubt and faith do not exist in the same person at the same time; so that persons whose minds are under doubts and fears cannot have unshaken confidence; and where unshaken confidence is not, there faith is weak." (Lectures on Faith, 6:12)
